Emerging Challenges in Internet Governance in North East India



Internet governance as a concept came to the view of the wider public with proceedings of the World Summit on the Information Society in 2003 and 2005 under the aegis of the United Nations (WSIS). There were a series of developments after that, the more major ones being the Working Group on Internet Governance (WGIG) in 2005 and Internet Governance Forum (IGF) in 2006. The purpose of the Internet Governance Forum is to provide a platform for multi-stakeholder debate and discussion on a wide range of themes. From the early days when internet governance was limited to discussions around critical systems required for the internet's functioning, the global fora on internet governance have increasingly attempted to address many issues which once would not have been possible. ### Internet Shutdowns In Meghalaya: Issues And Challenges For An Emerging Digital Society

Internet Shutdowns are defined as intentional disruptions in internet services by government authorities. This practice has been highly adopted in the Indian context, and according to Internet Shutdown Tracker (2022), India has registered 690 internet shutdowns. In addition, a report by SFLC.in titled Let the Net Work: Internet Shutdowns in India (2022) has provided a map of the distribution of reasons for internet shutdowns in India. It was found that terrorist threats accounted for 41 %, communal tension registered 24%, protests and political tension reported for 6 % and cheating in exams recorded 4 %. The duration of internet shutdowns varies from state to state and context to context. In the case of Meghalaya, internet shutdowns have been adopted a total of 16 times which have been spread out across different districts in the state. Gradually, this practice has become a reoccurring trend over the last few years. Read More

## Increasing Cyber Crimes threatening digital freedom and rights of Women: A Study in Mapping of Digital Vulnerabilities of Women in Assam and Telangana

The number of cyber crimes has been increasing over the years. According to the data, a total of 50,035 cases were registered under cyber crimes in 2020, showing an increase of 11.8% in




registration over 2019 (44,735 cases). 60.2% of cyber-crime cases registered were for the motive of fraud (30,142 out of 50,035 cases) followed by sexual exploitation with 6.6% (3,293 cases) and Extortion with 4.9% (2,440 cases)1.It is to be noted that the state of Assam does not fare very well in terms of gender equality as seen from the state's SDG indices. Cyber crimes against women can be

divided into numerous categories like sexual harassment or exploitation, the violence of privacy, bullying, abuse, and publication or transmission of sexually obscene and explicit content. Cyber crimes against women represent not only a violation of women's human rights but also indicated the condition of women in a particular society. Read More

#### **Connecting Himalayan Communities**

The Himalayas is a mountain range globally recognised as a hotbed of ecological biodiversity. It spreads over 2500 km in length and is estimated to be 300 km wide. The region encompasses ecologically sensitive zones and is home to many ethnicities, economies and cultures. Typically, the



Himalayas pass through countries such as India, Pakistan. Nepal. Afghanistan, Bhutan, China. Myanmar and Bangladesh (Rao, Saxena and Tiwari. 2015). However, the degree of Himalayan coverage can vary from part to fully. frontiers These sensitive ecological zones with the paradoxical characteristic of being remote and possibly a bridge between

geopolitical imagination of nations and states. Furthermore, the geographical landscapes are biodiversity hotspots ranging from foothills, lush grasslands, valleys and steep mountain slopes; each carrying its local economy, challenges and resources.

According to the Human Development Index (UNDP, 2022), the Himalayan countries ranked poorly; Bhutan ranked the highest at 127, and Afghanistan ranked the lowest at 180. This generally is a reflection of the quality of life of the population. Read More

# 'Be Internet Awesome': Google Teams Up With Assam Govt To Drive Digital-Led Learning Among Youth.

Google and Assam's Skill, Employment & Entrepreneurship Department (SEED) have partnered to promote digitally guided learning and skill development among the state's youth. Additionally, the principles of online safety and digital citizenship will be promoted through this collaboration. The programme will improve students' digital literacy. preparing them to be future leaders and safe internet users

According to a release, Google will work with the Assam Skill Development Mission

(ASDM) to offer scholarships to Assamese youngsters for Google Career Certificates. In accordance with the agreement, Google will work with ASDM to offer scholarships and comprehensive training to kids so they can meet the demand for digital skills.

The programme will help qualifying candidates seek Google career credentials in popular categories including project management, data analytics, IT support, and IT automation, among others.

Assam Governor Prof. Jagdish Mukhi introduced the "U-Report" for the Suraksha Campaign for the state's youth. The National Service Scheme volunteers who participated in Covid 19 chose cyberbullying and physical punishment as two concerns that The U Report, an interactive digital tool, will centre on. The U-Report for Suraksha campaign is an interactive digital tool that attempts to raise youths' awareness of corporal punishment, cyberbullying, and the redress processes.

Once a U-Reporter has liked the U-Report India Facebook Page or followed @UReportIndia on Twitter, quizzes and alerts are delivered through direct message, and replies are gathered in real-time on this website.

The community of young people and policymakers are informed of the findings and proposals. U-Report India has so far covered topics such as youth unemployment, HIV/AIDS, illness outbreaks, and water, sanitation, and hygiene challenges.

### Three Digital Banking Units Launched In Sikkim

To promote financial inclusion in India, Prime Minister Narendra Modi launched 75 Digital Banking Units (DBUs) on Sunday. It will "simplify the banking process," according to Modi, and offer a "strong and secure" financial system.

DBUs are used in Sikkim to give distant areas in the region access to digital banking. Both self-aided zones and digitally assisted zones make up the DBU's two sorts of inventory. In a self-assisted zone, consumers can just walk in and start transactions other their and banking-related activities because they are familiar with how the facility works. The DBU staff gives necessary assistance and support to the customer in carrying out their required banking activities in the digital-assisted zone, he said. Read more

## Manipur boy develops mobile app in less than a week

Baldeep Ningthoujam, who is from Kha-Naorem Leikai, Canchipur in Imphal East, has launched his own mobile app called "Scanner Call" in Imphal.

He finished the app in less than a week. In the past, Baldeep had created a number of websites and applications, such as "E-Thabak," "Receipt App," and the game "Coroboi," all of which were made available during the Covid pandemic in 2020. The "Scanner Call" app, which may currently be found on the Play Store, gives users access to the phone numbers found in an image.

According to Baldeep, users can capture a new image using the phone's camera or quickly retrieve one from the gallery. The app will then detect all the phone numbers in the image and allow users to choose any of them without having to type the digits in again.

He noted that the programme would be quite helpful, particularly when handling a long list of phone numbers or while the user is multitasking.

He added, "New functions will be made available in this app soon." Additional updates to the software are already planned, including the addition of many functionalities including OR scan, text scan, and others. Read more

## Arunachal CM Launches e-ILP Portal To Facilitate Movement Of Tourists

The online eILP Portal, a web-based tool for the hassle-free issue of Inner Line Permit (e-ILP) to tourists, was launched by the chief minister of Arunachal Pradesh, Pema Khandu, on Thursday.

The Arunachal CM hailed its launch as "a great step to serve exclusively the tourists and smoothen their entry into the state, thereby facilitating the process of obtaining Inner Line Permit (ILP)" after it was created by the IT Department of Arunachal Pradesh in partnership with the National Informatics Center (NIC).

Tourists will travel more quickly thanks to "ID card-based registrations with mobile OTP-based self-verification and QR Code-based digitally issued

ILP, which can be validated by police personnel at check gates using the specially built mobile-based application," the CM continued.

To allow an Indian citizen to enter a protected or restricted location for a brief length of time, the ILP involves a permit for official travel documents granted by the Central government.

ILP, a rule from the British era, requires all Indian citizens to obtain a special permit for entry into the border states and territories of North-East India in order to protect the ethnicity and culture of the northeastern tribals.
